A CCTV system is to be installed to the satisfaction of the Sussex Police, with cameras covering the alcohol displays, the tills and the entrance. The images will be stored for 31 days, and made available on Police and Licensing Authority request.

A refusals recording mechanism, either book or computer, shall be maintained at the premises. These records shall be made available for inspection by Police officers, PCSOs, and the Police and Local Authority Licensing Officers.

All staff will be subjected to training and regular re-training regarding the prevention of sales to or on behalf of underage persons and to drunk persons. (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5.

The responsible person shall ensure that -

(a) there any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) beer or cider: ½ pint;

(ii) gin, rum, vodka, whisky: 25ml or 35ml; and

(iii) still wine in a glass: 125ml; and

(b) customers are made aware of the availability of these measures.

Annex 2 - Conditions consistent with the Operating Schedule

General

Through point of sale material, ensure members of public and staff are made aware of the criteria for the sale of alcoholic beverages. This will also be trained to the staff in order to comply with all the rules and regulations.

As age sensitive products, such as Lottery and cigarettes are being sold at the premises, the same care to identify age will be adhered to.

The Prevention of Crime & Disorder

Liaise with local police to ensure no action is taken to encourage this.

Will not sell alcohol to persons appearing to be excessively intoxicated.

Public Safety

Ensure any packaging and damaged containers are disposed of sensibly.

The Prevention of Public Nuisance

Liaise with local police to ensure no action is taken to encourage this.

Will not sell alcohol to persons appearing to be excessively drunk.

The Protection of Children from Harm

Ensure that checks are carried out to identify that persons above the legal age only can purchase the products.

Annex 3 - Conditions attached after a hearing by the Licensing authority

(i) Mandatory condition - s19 Licensing Act 2003

(ii) CCTV monitoring system is to be maintained. Recordings will be kept securely for a minimum of 28 days and shall be made available to police on reasonable request.

(iii) A refusals recording mechanism detailing all items that are refused, is to be maintained and kept at the premises. This should detail the date and time of refusal, item refused and name or description of person attempting to purchase the item. This will be available to police officers, police community support officers and licensing staff on request.

(iv) Staff are to be regularly trained regarding the limitations on the sale of alcohol. Training records should be signed by the trainee and be made available on request to police officers, police community support officers and licensing officer on request.

(v) There shall be a minimum of two staff present at the premises when the sale of alcohol takes place.
