3. There shall be no more than 2 entertainers providing live music at any one time.
4. The outside areas shall be used for smoking only and no drinks, food or entertainment shall be provided outside.
5. All alcohol supplied by the premises, is supplied by waiter/waitress service to persons seated at tables consuming bona fida sit down meals. There shall be no 'vertical' drinking and no service to customers at the bar, including persons awaiting their takeaway meal.
6. Alcohol sold with a takeaway meal will only be supplied with the takeaway, which will not be consumed within the immediate vicinity or in the premises.
7. All alcohol supplied to be taken away from the premises, will be supplied in properly sealed containers.
8. Any customer who appears under the age of 25 years will be asked to provide identification of their age.

" The Event is for community activities but shall have the facility to provide alcohol from a bar or bars, which shall have at least one personal licence holder in attendance at all times licensable activity is taking

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
