Sompting Neighbourhood Plan Area Designation

Report by the Executive Head of Planning, Regeneration and Wellbeing

1.0 Summary

1.1 Sompting Parish Council is intending to produce on behalf of its local community a Neighbourhood Plan in order to address issues facing the area (those which arise from a current consultation exercise being conducted by the Parish Council). In line with the Neighbourhood Planning (General) Regulations 2012, the Parish Council submitted to Adur District Council as well as to the South Downs National Park Authority (SDNPA) an application for the designation of the area to be covered by the Neighbourhood Plan. This application (which includes a map of the area) is appended. In line with the Regulations, this application was advertised in the local press and on the District and Parish Council's web sites for a 6 week period from the 10th October 2012 to 23rd November 2012. No representations were received by the District Council nor by the SDNPA during this period and it is therefore recommended that the designation of the area be approved.

2.0 Background

- 2.1 The production of Neighbourhood Plans is a new power introduced by the Localism Act 2011 which enables Parish Councils to plan how their communities will change and develop in the future.
- 2.2 The procedures for producing a Neighbourhood Plan are set out in the Neighbourhood Planning (General) Regulations 2012, which came into force on 6th April 2012.
- 2.3 The first step for a Parish Council is to submit to the Local Planning Authority an application for the designation of the area to be covered by each Neighbourhood Plan. A Parish Council may choose to produce a Neighbourhood Plan that covers all or part of its parish. They must submit to the local planning authority the following:
 - (a) A map which identifies the area to be covered by the Neighbourhood Plan;
 - (b) A statement explaining why the area concerned is appropriate; and
 - (c) A statement that the Parish Council is a relevant body for the purposes of section 61G of the Town and Country Planning Act 1990 (as amended).

- 2.4 For the majority of Adur district, the local planning authority is the District Council. However, for those parts of Adur which lie within the South Downs National Park, applications for the designation of Neighbourhood Plan Areas must be made to the South Downs National Park Authority (SDNPA). For a Parish which straddles both areas, an application must be made to both Authorities.
- 2.5 In line with the Regulations, an application was submitted by the Parish Council to the District Council as well as the SDNPA. The application (appended) consists of the letter of the 13th September 2012 to the Council's Planning Policy Manager and a map of the whole Parish Area. The letter states that the area to be designated for a neighbourhood plan is appropriate because it is a properly constituted Parish within the planning authorities of Adur District Council and the SDNPA. The application was publicised between the 10th October and the 23rd November 2012 in the following ways:
 - An advertisement was placed in the local paper (in the Heralds and the West Sussex Gazette) and on the Council's website.
 - The details and documentation was placed on the District Council's and SDNPA's websites.
 - The application was advertised on the Sompting Parish Council notice board.

3.0 Response

3.1 No representations have been received on the application by either the District Council or by the SDNPA. Accordingly, it is recommended that approval is given to the designation of the Sompting Neighbourhood Plan Area.

4.0 Legal

- 4.1 The Localism Act 2011 amended the Planning and Compulsory Purchase Act 2004 to provide for neighbourhood development plans to be applied for.
- 4.2 The processes involved in designating the Sompting Neighbourhood Plan area are in accordance with the Neighbourhood Planning (General) Regulations 2012.

5.0 Financial implications

5.1 There are costs in producing a Neighbourhood Plan to be borne by both the Parish Council and by the District Council. However, Communities and Local Government Dept (CLG) is providing some funding support and once the designation of the area for the Sompting Neighbourhood Plan is approved then a request for funding will be made by Adur District Council. CLG is currently providing £5,000 following an area designation and £25,000 on successful completion of the Neighbourhood Plan examination. The £5,000 is to recognise officer time supporting and advising the community in taking forward a neighbourhood plan. The £25,000 is to cover costs for the examination and any other further steps that may be needed for the neighbourhood plan to come into legal force, including the referendum. The request for payment, if approval is given to the designation of the area before the 31st December, has to be made by the 8th January 2013.

6.0 Recommendation

6.1 It is recommended that the designation of the Sompting Neighbourhood Plan area be approved.
