

Licensing Act 2003 - Applications completed in 2021

Please find below a list of Licensing Act 2003 applications completed since 1 January 2021 by the Licensing Authority, Adur District Council, for new Premises Licences, Variations to existing Premises Licences and Review applications.

The terms of the Licensing Act 2003 dictate that all 'new' applications and 'variation' applications are publicised and consulted on. If no representations are received from 'Responsible Authorities' or any other persons such applications must be granted as applied for. If relevant representations are received and mediation between the parties is unsuccessful then the application has to be deliberated by the Licensing Committee following a hearing.

'Minor variations' are also consulted on but only by 'public notice' on the premise, details posted on this website and any responsible authorities the licensing authority selects as relevant. If relevant representations are received and considered by officers to have implications under the licensing objectives then the application is simply rejected and a full variation has to be applied for.

'Review' applications are consulted on by public notices being displayed on the premise and on the licensing authority's notice board situated at the Shoreham Centre. Details are posted on this website and copies of the application are served on the licence holder and responsible authorities. Review applications cannot be withdrawn unless a licence is surrendered and must be heard by the Licensing Committee whatever agreement mediation may produce.

Spirit of the Downs

Committee Hearing: Held on Monday 13 September 2021

In reaching its decision the Licensing Committee gave due regard to the following:

- The statutory licensing objectives
- Adur District Council's Statement of Licensing Policy
- Guidance under section 182 by the Home Secretary and Licensing Act 2003
- The application, written and oral representations made at the hearing and in writing

The Committee also gave regard to human rights legislation and the rules of natural justice In discharging its functions the Committee did so with a view to promoting the Licensing objectives, the relevant objectives here were the prevention of crime and disorder, the prevention of public nuisance, public safety and protection of children from harm.

The Committee resolved that a provisional statement be granted.

The Committee considered that the Applicant had taken into account the concerns of the local residents. The Council received 195 representations from local residents. Concerns raised included parking issues, loss of green space, no requirement or demand for a licensed premise, damage to the beach and nature reserve and viability those concerns were deemed irrelevant under the legislation to this application and were disregarded by the Committee. The residents also raised concerns about increased anti-social behaviour, noise pollution, litter and concerns over the impact that an alcohol licence would have on children and unaccompanied children using the toilets within the building. These concerns being relevant to this application and were considered.

The licencing committee considered the relevant representations but was satisfied that, with the additional conditions volunteered by the applicant in agreement with Sussex Police and the amendments made by the applicant to address some public concerns, the issuing of a provisional statement to include the conditions & amended timings offered would not undermine the licencing objectives.

One Stop

An application for a new premises licence to allow alcohol sales at a new convenience store to be known as the 'One Stop'. The store is to be situated at 135-137 South Street, Lancing, BN15 8BD.

The application sought authorisation for the sale of alcohol for consumption off the premises.

Committee Hearing: Held on Thursday 12 August 2021

A number of representations have been received from members of the public regarding this application and consequently it was referred to the Licensing Committee for consideration. The meeting was held online via

The Committee considered all the written & oral representations and heard statements from the applicant and members of the public. It resolved that a Premises Licence be granted but imposed the amended timings volunteered by the applicant at the hearing (07:00hrs to 23:00hrs Mon - Sun) and all the conditions agreed during mediation with Sussex Police prior to the hearing.

The reasons for the decision were:

The Committee considered:

- The representations made by the Responsible Authority and members of the public.
- The mediation during which the applicant had offered to amend the operating schedule to include licence conditions suggested by Sussex Police being placed on the licence.
- The amended hours offered by the applicant during the hearing and
- The remaining relevant representations which had not been withdrawn.

In discharging its functions the Committee did so with a view to promoting the Licensing objectives.

The licencing committee listened carefully and considered all written and oral representations that had been made. They believe that together the amended hours that were offered by the applicant and the additional conditions agreed with Sussex police the licencing objectives will be promoted and not be undermined.

Railway Inn

An application for a new 'mirror' premises licence to authorise alcohol sales for consumption on & off the premises and the provision of regulated entertainment at the 'Railway Inn'. The venue is situated at 1 North Road, Lancing, BN15 9AH.

For a minor variation application, in addition to the statutory public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application.
