Southern Water is pleased to note the inclusion of the provision for the delivery of essential utilities infrastructure in special circumstances within areas of open space, recreation and leisure as a result of the last consultation. However the addition of the following sentence at the end of the provision; '[...] any loss of open space should be in accordance with (iii) above' could restrict Southern Water's ability to deliver infrastructure, for example a pumping station, which would result in a negligible loss of open space, yet the need to find an 'equivalent or improved provision in terms of quantity and quality' could preclude development.

The addition of this clause creates an inflexibility of policy in certain circumstances. Planning Practice Guidance on Water supply, wastewater and water quality (paragraph 005 - Infrastructure) states; 'In identifying sites it will be important to recognise that water and wastewater infrastructure sometimes has particular locational needs (and often consists of engineering works rather than new buildings) which mean otherwise protected areas may exceptionally have to be considered where consistent with their designation.' (our underline) In certain cases the requirement for small new buildings may not justify the provision of an equivalent quantity of open space.

Southern Water understand the Council's desire to seek replacement of open space lost to substantial development, but would wish the council to acknowledge that an exception should be made for circumstances where the loss of space is not significant.
