TERMS AND CONDITIONS

Concessions are available to stall holders at markets at a flat daily charge of £4.00. For High Street Surface Car Park payment is to be made at the Pay and Display Machine. For High Street MSCP or Buckingham Road MSCP payment is to be made at the Pay on Foot Pay machines.

Abuse of the validation concession (i.e. where it is established that customers are not working officially as part of a market within the Worthing area), will result in the validation concession being cancelled immediately and the vehicle issued with a Penalty Charge Notice. Validation concessions are not transferable between the car park sites.

Validation concessions are not transferable between vehicles.

A validation concession is not a guarantee of a parking space.

Applications are required to be made 28 days prior to the event.
