Thank you for your consultation correspondence of 14th June regarding the Adur Local Plan Main Modifications Consultation.

Highways England has been appointed by the Secretary of State for Transport as strategic highway company under the provisions of the Infrastructure Act 2015 and is the highway authority, traffic authority and street authority for the strategic road network (SRN). The SRN is a critical national asset and as such Highways England works to ensure that it operates and is

Our position has not changed since signing the Statement of Common Ground but you will need to be aware that we have recently started our public consultation on our RIS scheme the A27 Worthing and Lancing Improvements. Your council is of course a statutory consultee and Adur colleagues should have all of the necessary information. If this is not the case please contact me again and I will ensure that you are sent the relevant documents.
