To ensure that this investment can be realised, the Council has previously resolved to dispose of the site. However, this is only a leasehold basis and on the proviso that public toilets are re-provided in any redevelopment. The community asset would be re-provided in any event. As a result, it is not considered that the building in its current condition constitutes a community asset worthy to be added to the Register.
