

Licensing Act 2003 - Applications completed in 2023

Please find below a list of Licensing Act 2003 applications completed since 1 January 2023 by the Licensing Authority, Worthing Borough Council, for new Premises Licences, Variations to existing Premises Licences and Review applications.

The terms of the Licensing Act 2003 dictate that all 'new' application and 'variation' applications are published and consulted on. If no representations are received from 'Responsible Authorities' or any other persons such applications must be granted as applied for. If relevant representations are received and mediation between the parties is unsuccessful then the application has to be deliberated by a sub-committee of the Licensing & Control Committee B following a hearing.

'Minor variations' are also consulted on but only by 'public notice' on the premises, details posted on this website and any responsible authorities the licensing authority selects as relevant. If relevant representations are received and considered by officers to have implications under the licensing objectives then the application is simply rejected and a full variation has to be applied for.

'Review' applications cannot be withdrawn unless a licence is surrendered and must be heard by the full Licensing Committee B whatever agreement mediation may produce.

North Star

An application for a 'minor variation' to the premises licence at the North Star public house situated in Littlehampton Road, Worthing, BN13 1QY. The licence authorises the sale of alcohol for consumption on & off the premises, the provision of regulated entertainment and the provision of late night refreshment.

The application sought to vary the existing licence to:

• Authorise changes to the layout of the premises as part of a refurbishment

No other changes were proposed by the application.

Licence holder and applicant: Mitchells & Butlers Leisure Retail Ltd.

Consultation closed: Wednesday 20 December 2023 **Committee Hearing:** Not required for a minor variation.

For a minor variation application, in addition to the statutory 10 working day public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the layout of the pub & garden, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representation were received from members of the public or the authorities consulted. After due consideration officers consider the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation has been granted as per the terms of the Licensing Act 2003.

Toni & Guy

An application for a new premises licence at an established hair & beauty salon known as 'Toni & Guy'. The premises is situated at 54 South Street, Worthing, West Sussex, BN11 3AA.

The application sought authorisation for the sale of alcohol for consumption on the premises.

- Opening to the public:

The applicant offered a set of conditions in the operating schedule to address the licensing objectives.

Consultation closed: Tuesday 12 December 2023 **Committee Hearing:** Cancelled - not required.

The application received no relevant representations from the public, but one was received from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the representor's concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result the representation was withdrawn and consequently, an amended application was granted as per the terms of the Licensing Act 2003.

Slicks Sports & Bars

An application for a 'full variation' to the premises licence at the 'Slicks Sports & Bars'. The venue is situated at 19-23 South Street, Worthing, West Sussex, BN11 3AW.

The licence authorises the sale of alcohol for consumption on & off the premises, the provision of regulated entertainment and the sale of late night refreshment.

The application sought to authorise:

- An extension of the licensed area on the ground floor to incorporate a 12 hole indoor crazy golf course
- Amendment of the following conditions of licence:
 - Condition 14 which states: All children under 16 years of age must be accompanied by an adult
 - Condition 15 which states: No persons under 18 years of age shall be allowed in the premises after 22:00hrs

To allow:

- Children under 16 years of age to be allowed in the premises until 19:00hrs without an adult and until 22:00hrs with an adult
- o 16 and 17-year-olds to be allowed on the premises until 22:00hrs without an adult

No other changes are proposed.

Licence holder and applicant: Slicks Sports & Bars (Worthing) Ltd.

Consultation closed: Tuesday 28 November 2023 **Committee Hearing:** Cancelled - not required.

Re-scheduled due to applicants failure to advertise the application in accordance with the regulations.

Once advertised in compliance with the act the application received no relevant representation from members of the public, but one was received from a responsible authority, Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the Police's concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result the representation was withdrawn and consequently, the amended application was granted as applied for as per the terms of the Licensing Act 2003.

Efes Town Turkish Cuisine

An application for a 'minor variation' to the premises licence at Efes Town Turkish Cuisine situated at 18-20 Portland Road, Worthing, West Sussex, BN11 1QN. The licence authorises the provision of late night refreshment and the sale of alcohol for consumption on the premises.

The application sought to vary the existing licence to:

• Authorise changes to the layout of the premises

No others are proposed by the application.

For a minor variation application, in addition to the statutory 10 working day public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the layout of the restaurant, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representation were received from members of the public or the authorities consulted. After due consideration officers consider the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation has been granted as per the terms of the Licensing Act 2003.

McColls - Heene Road

An application for a 'minor variation' to the premises licence at the McColls store situated at 62-66 Heene Road, Worthing, BN11 3RG. The licence authorises the sale of alcohol for consumption off the premises.

The application is seeking to vary the existing licence to:

- Change the name of the business to 'Morrisons Daily'
- Authorise changes to the layout of the premises as part of a refurbishment

No other changes are proposed by the application.

Licence holder and applicant: Alliance Property Holdings Ltd.

Consultation closed: Thursday 23 November 2023 **Committee Hearing:** Not required for a minor variation.

For a minor variation application, in addition to the statutory 10 working day public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the layout of the store, Sussex Police WSCC Fire & Rescue service and the A&W Environmental Health Team were consulted.

No formal representation were received from members of the public or the authorities consulted. After due consideration officers consider the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation has been granted as per the terms of the Licensing Act 2003.

Forest Row

An application for a new premises licence for a bar & food court to be known as 'Forest Row'. The premises will be situated at 14 Liverpool Buildings, Liverpool Road, Worthing, BN11 1SY.

The application sought authorisation for the sale of alcohol for consumption on & off the premises and the provision of regulated entertainment in the form of plays, films, indoor sporting events, performance of dance and anything similar.

The applicant offered a set of conditions in the operating schedule to address the licensing objectives.

Licence holder and applicant: Forest Row Worthing Ltd. **Consultation closed:** Monday 20 November 2023 **Committee Hearing:** Cancelled - not required.

On successfully completing the consultation the application received no relevant representation from the public, but one was received from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the representor's concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result the representation was withdrawn and consequently, an amended application was granted as per the terms of the Licensing Act 2003.

Worthing Gyros

An application for a new premises licence for a restaurant to be known as 'Worthing Gyros'. The premises will be situated at Unit 3, The Montague Centre, Worthing, BN11 1YJ.

The application sought authorisation for the sale of alcohol for consumption on & off the premises, the provision of regulated entertainment in the form of recorded music and the provision of late night refreshment.

The application received one relevant representation from a member of the public and one was received from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing both representors' concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result the representations were withdrawn and consequently, the amended application was granted as per the terms of the Licensing Act 2003.

Worthing Pavilion Bowling Club

An application for a new premises licence for an established sports club known as 'Worthing Pavilion Bowling Club'. The club is situated at 78 Pavilion Road, Worthing, BN14 7EQ.

The application sought authorisation for the sale of alcohol for consumption on the premises and the provision of indoor sporting events.

These activities are currently authorised by a Club Premises Certificate for provision to members and their bona fide guests, but the club now wishes to admit members of the public so requires a premises licence.

The applicant offered a set of conditions in the operating schedule to address the licensing objectives.

Licence holder and applicant: Worthing Pavilion Bowling Club Ltd.

Consultation closed: Friday 10 November 2023 **Committee Hearing:** Cancelled - not required

The application received no relevant representation from members of the public, but one was received from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the Police's concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result the Police withdrew their representation and consequently, the amended application was granted as applied for as per the terms of the Licensing Act 2003.

The Moon by Sea

An application for a new premises licence for a new café/bar/restaurant to be known as 'The Moon by Sea'. The café is to be situated at Unit 2, 28 Goring Road, Worthing, BN12 4AD.

The application sought authorisation for the sale of alcohol for consumption on & off the premises.

- Opening to the public:
 - o 08:00hrs to 23:00hrs Monday to Sunday incl.

The applicant offered a set of conditions in the operating schedule to address the licensing objectives.

Licence holder and applicant: Little Green Apples Ltd. Consultation closed: Thursday 9 November 2023 Committee Hearing: Cancelled - not required.

The application received no relevant representation from members of the public, but two were received from responsible authorities - A&W Environmental Protection Team and Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the Authorities' concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result both authorities withdrew their representations and consequently, the amended application was granted as applied for as per the terms of the Licensing Act 2003.

McColls - The Strand

An application for a 'minor variation' to the premises licence at the McColls store situated at 7-9 Strand Parade, Worthing, BN12 6DH. The licence authorises the sale of alcohol for consumption off the premises.

The application is seeking to vary the existing Licence to:

- Change the name of the business to 'Morrisons Daily'
- Authorise changes to the layout of the premises as part of a refurbished
- Amend the Challenge 25 condition of licence to add a number of forms of identification

No other changes are proposed by the application.

Licence holder and applicant: Alliance Property Holdings Ltd.

Consultation closed: Friday 3 November 2023

Committee Hearing: Not required for a minor variation

For a minor variation application, in addition to the statutory 10 working day public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the layout of the store and to a condition of licence that could potentially have implications affecting the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representations were received from members of the public or the authorities consulted. After due consideration officers consider the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation has been granted as per the terms of the Licensing Act 2003

An application for a new premises licence for a restaurant & bar to be known as 'Alchemy Sussex'. The premises will be situated at 28 The Guildbourne Centre, Worthing, BN11 1LZ.

The application sought authorisation for the sale of alcohol for consumption on & off the premises.

- Opening to the public:
 - o 08:00hrs to 23:30hrs Monday Sunday

The applicant offered a set of conditions in the operating schedule to address the licensing objectives.

Consultation closed: Tuesday 24 October 2023
Committee Hearing: Cancelled - not required.

The application received no relevant representation from members of the public, but one was received from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the Police's concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result the Police withdrew their representation and consequently, the amended application was granted as applied for as per the terms of the Licensing Act 2003.

Express Supermarket

An application for a review of the premises licence at 'Express Supermarket' under section 51 of the Licensing Act 2003.

The store is situated at 68-70 Newland Road, Worthing, West Sussex, BN11 1JX. The store's premises licence permits the sale of alcohol for consumption off the premises between 08:00hrs and 23:00hrs Monday to Saturday and between 10:00hrs and 22:30hrs on Sunday.

The application was submitted by WSCC Trading Standards Service following licensing checks that showed a number of breaches to the conditions of licence and the sale of alcohol by a member of staff at the store to a Trading Standards volunteer who was under the age of 18 during a controlled Trading Standards test purchasing exercise. The applicant has requested that the Licensing Authority considered:

A suspension of the licence for 3 months and removal of the Designated Premises Supervisor (DPS).

The grounds for the review being the applicant's contention that the licence holder & DPS have undermined the following licensing objectives:

The Prevention of Crime and Disorder The Protection of Children from Harm

Licence holder and applicant: Mr Arumugam Balachandran / WSCC Trading Standards Service

Consultation closed: Wednesday 20 September 2023 **Committee Hearing:** Held on Wednesday 18 October 2023

The application received no representations from the public but did receive two representations from responsible authorities supporting Trading Standards case. These were from Sussex Police and WSCC Public Health. Both authorities, as well as endorsing the application's contention that the licence should be suspended and the DPS replaced, recommended a number of conditions to be imposed to promote the licensing objectives.

At the hearing the Sub-Committee considered all the written and oral representations from the applicant, representors and licence holder.

It resolved to impose all of the additional conditions on the licence that had been suggested by the responsible authorities and agreed/offered by the licence holder.

In reaching its decision the Licensing Sub-Committee gave due regard to the following:

- The statutory licensing objectives
- Worthing Borough Councils Statement of Licensing Policy
- Guidance under section 182 by the Home Secretary and Licensing Act 2003
- The application, written/oral representations made at the hearing and in writing
- The Committee also gave regard to human rights legislation and the rules of natural justice.

In discharging its functions the Committee did so with a view to promoting the Licensing Objectives, the relevant objectives here were the Prevention of Crime & Disorder and the Protection of Children from Harm.

The Committee listened carefully to all of the parties and felt that the premise licence holder had taken steps to ensure that the licence objectives will be promoted with all of the additional conditions that were agreed. Although a deterrent to other business was considered it was not felt proportionate in these circumstances with the change of DPS, removal of the member of staff that had sold alcohol to the underage child and acceptance of the additional conditions which proved to the committee that the licence holder had taken this matter seriously.

Donchevi Kitchen

An application for a new premises licence for an established restaurant known as 'Donchevi Kitchen'. The restaurant is situated at 10 Montague Place Worthing, West Sussex, BN11 3BG

The application sought authorisation for the sale of alcohol for consumption on & off the premises.

- Sale of alcohol:
 - o 09:30hrs to 22:30hrs Monday Sunday incl.
- Opening to the public:
 - o 09:00hrs to 23:00hrs Monday to Sunday incl.

The applicant offered a set of conditions in the operating schedule to address the licensing objectives.

The premises had been licensed previously but on a technicality the licence had lapsed.

Licence holder and applicant: Donchevi Group Ltd. **Consultation closed:** Tuesday 17 October 2023 **Committee Hearing:** Cancelled - not required.

Re-scheduled due to applicants failure to advertise the application in accordance with the regulations.

Once advertised in compliance with the act the application received no relevant representation from members of the public, but one was received from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the Police's concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result the Police withdrew their representation and consequently, the amended application was granted as applied for as per the terms of the Licensing Act 2003.

Thai Street Food

An application for a 'minor variation' to the premises licence at 'Thai Street Food' (formerly known as Cocks Kitchen). The restaurant to be located at 98-100 Brighton Road, Worthing, BN11 2EN. The licence authorises the sale of alcohol for consumption on & off the premises and the provision of regulated entertainment. The application sought to vary the existing Licence to authorise:

- Minor alterations to the layout of the restaurant as part of a refurbishment.
- Removal of the condition of licence that states: The maximum number of customers that will be
 present at the premises (inside the café and on the forecourt) at any one time will be limited to 24
 persons.

No other changes were proposed.

Licence holder and applicant: Ms Yamin Panyapetch & Mr Jack Lee-Francis

Consultation closed: Wednesday 11 October 2023 **Committee Hearing:** Not required for a minor variation

For a minor variation application, in addition to the statutory 10 working day public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved minor changes to the layout of the premises and removal of a condition of licence that could potentially have implications affecting the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

On this occasion the applicant, after consultation with Sussex Police, agreed to add the following condition to the premises' operating schedule:

• The maximum number of persons permitted on the premises at any one time shall not exceed the safe capacity figures prescribed following the requisite Fire Safety Risk Assessment.

No formal representations were received from members of the public or the authorities consulted. After due consideration officers consider the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation was granted as per the terms of the Licensing Act 2003.

Jungle Nightclub

An application for a 'minor variation' to the premises licence at 'Jungle Nightclub'. The venue is situated at 31 Chatsworth Road, Worthing, BN11 1LY. The licence authorises the sale of alcohol for consumption on the premises, the provision of regulated entertainment and late night refreshment. The application sought to vary the existing Licence to authorise:

• Minor alterations to the layout of the club including re-opening of a refurbished front bar.

No other changes were proposed.

Licence holder and applicant: Jungle Nightclub Ltd. **Consultation closed:** Tuesday 3 October 2023

Committee Hearing: Not required for a minor variation

For a minor variation application, in addition to the statutory 10 working day public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved minor changes to the layout of the premises that could potentially have implications affecting the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representations were received from members of the public or the authorities consulted. After due consideration officers consider the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation was granted as per the terms of the Licensing Act 2003

An application for a 'minor variation' to the premises licence at the McColls store situated at 1-2 Limbrick Corner, Palatine Road, Worthing, BN12 6JJ The licence authorises the sale of alcohol for consumption off the premises.

The application sought to vary the existing Licence to:

- Change the name of the business to 'Morrisons Daily'
- Authorise changes to the layout of the premises as part of a refurbished

No other changes were proposed.

Licence holder and applicant: Alliance Property Holdings Ltd.

Consultation closed: Monday 18 September 2023 **Committee Hearing:** Not required for a minor variation

For a minor variation application, in addition to the statutory 10 working day public consultation, the Licensing Authority has the discretion to consult any responsible authorities it considers necessary and relevant to the type of application. In this case, as it involved changes to the layout of the store that could potentially have implications affecting the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representations were received from members of the public or the authorities consulted. After due consideration officers consider the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation has been granted as per the terms of the Licensing Act 2003

Vault

An application for a review of the premises licence at the 'Vault' under section 51 of the Licensing Act 2003.

The venue is situated at Basement Bar, 32-34 Marine Parade, Worthing, West Sussex, BN11 3QA. The venue's premises licence permits the sale of alcohol for consumption on the premises between 12:00hrs and 03:00hrs (of the following morning) Monday to Sunday and the provision of recorded music indoors between 12:00hrs and 03:30hrs (of the following morning) Monday to Sunday.

The application was submitted by Sussex Police and requested that the Licensing Authority considered:

• Revocation of the licence

The grounds for the review being the applicant's contention that the licence holder and designated premises supervisor had undermined the following licensing objectives:

- The Prevention of Crime and Disorder
- Public Safety
- The Protection of Children from Harm

Licence holder and applicant: La Room Worthing Ltd / Sussex Police

Consultation closed: Friday 18 August 2023

Committee Hearing: Held on Wednesday 13 September 2023

The Sub-Committee considered all the written & oral representations from the applicant, the representor and licence holder. It resolved that the premises licence should be revoked

The Sub-Committee determined that the concerns raised by Sussex Police related to various breaches of licence conditions, failure to provide CCTV to assist the Police in their investigations, that persons under 18 years old had been allowed in the premises and served alcohol and that the Challenge 25 Policy was not being

properly utilised. Evidence was provided regarding these breaches and that they had occurred more than once.

The Committee accepted the evidence before them that of the 13 incidents they were asked to consider three of them concerned persons under the age of 18 being in the premises and/or drinking. One incident was particularly disturbing of a child of only 17 who received life threatening injuries in a fight after drinking excessive alcohol at this premise.

The Committee recognised that Sussex Police had used a stepped approach with the premises and given guidance and support since the DPS had been in post. Sussex Police had worked with the premises and increased the licensing conditions in an attempt to stop the undermining of the licensing objectives. Evidence was before the committee of the advice that had been provided by Sussex Police and the failure of the stepped approach which had led to the review.

The Committee was satisfied that there had been multiple serious breaches of licence which had a huge impact on crime and disorder and the protection of children from harm and therefore to take no action was not an option for the committee or, in light of the comments from Sussex Police, to modify the conditions.

The Committee felt that the irresponsible trading of this premise needs to be stopped, and any other measure would be insufficient. This needs to serve as a deterrent to other businesses that breaches of licence conditions and repeated undermining of the licensing objectives will not be tolerated.

It was therefore considered just, proportionate and necessary to revoke the premise licence.

Cost Less Express

An application for a review of the premises licence at 'Cost Less Express' under section 51 of the Licensing Act 2003.

The store is situated at 31 South Farm Road, Worthing, West Sussex, BN14 7AD. The store's premises licence permits the sale of alcohol for consumption off the premises between 07:30hrs and 00:00hrs (midnight) Monday to Sunday.

The application was submitted by Sussex Police following a number of breaches to the licence and the sale of alcohol by a member of staff at the store to a Police volunteer who was under the age of 18 during a controlled Sussex Police test purchasing exercise. The applicant requested that the Licensing Authority considered:

Revocation of the licence

The grounds for the review being the applicant's contention that the following licensing objectives have been seriously undermined:

- The Prevention of Crime & Disorder
- The Protection of Children from Harm

Licence holder and applicant: Dimora Evolution Ltd / Sussex Police

Consultation closed: Friday 11 August 2023

Committee Hearing: Held on Tuesday 05 September 2023

The Sub-Committee considered all the written and oral representations from the applicant, representors and licence holder.

It resolved that the premises licence should be revoked.

The Sub-Committee determined that the concerns raised by Sussex Police and supported by WSCC Trading Standards and WSCC Public Health Directorate related to various breaches of licence conditions and that alcohol had been sold to a child on 31st May 2023. The Committee were extremely concerned to hear this had occurred as they take the licensing objectives of the prevention of crime and disorder and the protection of children from harm very seriously.

In addition, the Committee considered the evidence given by Sussex Police regarding three separate complaints about age restricted products being sold to children and numerous licence condition breaches.

The Committee deliberated the evidence that had been put before them at length. They felt that the evidence of the continued breach of licence conditions over a lengthy period of time and of the sale of alcohol to a child was very serious and significantly undermined the licensing objectives of the prevention of crime and disorder and the protection of children from harm.

In all of the circumstances, the Committee found that it was necessary and proportionate in order to promote the licensing objectives, to revoke the licence.

Tarring News & Wine

An application for a review of the premises licence at 'Tarring News & Wine' under section 51 of the Licensing Act 2003.

The store is situated at 3-4 Market House, Church Road, Tarring, West Sussex, BN13 1HF. The store's premises licence permits the sale of alcohol for consumption off the premises between 07:00hrs and 23:00hrs Monday to Sunday.

The application was submitted by WSCC Trading Standards Service following the sale of alcohol by a member of staff at the store to a Trading Standards volunteer who was under the age of 18 during a controlled Trading Standards test purchasing exercise. The applicant requested that the Licensing Authority considered:

• Revocation of the licence

The grounds for the review being the applicant's contention that the licence holder has undermined the following licensing objectives:

- The Prevention of Crime and Disorder
- The Protection of Children from Harm

Licence holder and applicant: Mr Gowriedas Kodeswaran / WSCC Trading Standards Service

Consultation closed: Thursday 10 August 2023

Committee Hearing: Held on Wednesday 30 August 2023

At the hearing the Sub-Committee considered all the written and oral representations from the applicant, representors and licence holder.

It resolved that the conditions of the Premises Licence be modified - namely the conditions at Annexe 2 of the current Premises Licence to be removed and to be replaced with a set of updated conditions detailed in the Police representation.

The Sub-Committee stated that it had considered the causes identified and what remedial action was needed to be directed at these causes.

Since the offence in May 2023 the business has been purchased by a new licence holder and a new DPS installed who has complied with both Trading Standards and the Police and has ensured his premises is now fully compliant with the licence conditions and, in addition, he has stated he will accept the more onerous conditions requested by the Police. As such, the Sub-Committee was of the opinion that with the changes to

the DPS and the enhanced Police conditions these are sufficient measures to promote the licensing objectives and that these are proportionate measures.

The Sub-Committee stated it would like to make it very clear that it does take this matter extremely seriously and it is only due to the changes made by the new operator that more serious action was not taken on this occasion, The Sub-Committee would be extremely disappointed should a further similar offence occur in the future.

Angels Bar & Nightclub

An application for a 'full variation' to the premises licence at the 'Angels Bar & Nightclub'. The venue is situated at 10 High Street, Worthing, West Sussex, BN11 1NU.

The licence authorised the sale of alcohol for consumption on & off the premises, the provision of regulated entertainment and the sale of late night refreshment. The licence currently authorises the provision of licensable activity:

- Alcohol Sales, Live Music, Recorded Music, Film, Indoor Sporting Events, Performance of Dance and Anything Similar

Committee Hearing: Held on Thursday 24 August 2023

Twenty-one relevant representations were received from members of the public and three were received from responsible authorities - Sussex Police, A&W Environmental Protection & WSCC Public Health. The Licensing Act encourages mediation and this was embarked on.

The mediation resulted in Sussex Police and the applicant agreeing a number of amendments to the application and operating schedule including amendment to the hours sought:

- Live music & recorded music:

- Removal of all the Non-Standard Timings and Seasonal Variations
- Removal of all the current conditions of licence listed under Annexe 2 of the premises licence to be replaced with a new set of updated and enforceable conditions covering CCTV, SIA Door staff provision, provision of an ID Scanner, policies on drugs & weapons, outside smoking area provision, incident recording, staff training, child access and others

Mediation had resulted in the A&W Environmental Protection Team (ECT) and the applicant agreeing a number of amendments to the application and operating schedule including the provision of a full noise insulation scheme drawn up by a qualified acoustician, tested and approved by the ECT before any extended operating hours commence.

However, mediation between the applicant and local residents was not successfully completed so the matter was referred to a Licensing & Control Sub-Committee to consider.

At the hearing the Sub-Committee considered all the written & oral representations and heard statements from the applicant and representors. It also considered the mediations reached prior to the hearing.

It resolved that the variation to the premises licence should be granted subject to the amendments to the application, detailed above, that were resolved during mediation with Sussex Police and the Environmental Protection Team (EPT)

The grant of the licence to be subject to all the relevant conditions volunteered by the applicant in the amended operating schedule and the mandatory conditions required by the Licensing Act 2003 and all other relevant legislation.

In discharging its functions the Sub-Committee did so with a view to promoting the Licensing objectives.

It was noted that the Applicant had met with some of the local residents prior to the hearing. However, the Sub-Committee was concerned to hear the representations from local residents regarding primarily noise and anti-social behaviour. Further, the Sub-Committee was informed that a Noise Abatement Notice had been issued on the

26th July 2023 but since then it was disappointing to note then the EPT had received further complaints regarding excessive noise.

The Sub-Committee carefully considered the mediated conditions and the agreed hours that were now significantly reduced. The updated conditions proposed being far more robust.

In addition, there were agreed conditions with the EPT including a condition stating there will be no variation to the operating hours until firstly a noise assessment is undertaken by a suitably qualified acoustician, that scheme will then be submitted to and approved by the EPT prior to being implemented. Following implementation the scheme will undergo testing by a qualified acoustician, if the detailed criteria have not been met a further scheme has to be implemented and agreed with the EPT.

As such, the Sub-Committee were of the opinion this condition, along with the mediated conditions with Sussex Police and the reduced opening hours were sufficiently robust not to undermine the licensing objectives.

Clifton Food & Wine

An application for a new premises licence for a convenience store known as 'Clifton Food & Wine'. The convenience store is situated at 123 Clifton Road, Worthing, West Sussex, BN11 4DP.

The application sought authorisation for the sale of alcohol for consumption off the premises.

No relevant representation was received from members of the public, but one was received from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the Authority's concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result the Police withdrew their representation and consequently, the amended application was granted as applied for as per the terms of the Licensing Act 2003.

The Grand Victorian Hotel

An application for a 'minor variation' to the premises licence at the 'Grand Victorian Hotel'. The hotel & public house is situated at 27 Railway Approach, Worthing, BN11 1UR. The licence authorises the sale of alcohol for consumption on & off the premises, the provision of regulated entertainment and the sale of late night refreshment.

The application sought to vary the existing Licence to:

- Change the name of the business to 'The Railway Hotel'
- Remove a number of obsolete converted conditions carried over from the old 1964 justices' liquor licence and the old public entertainment licence.

No other changes were proposed.

An application for a new premises licence for a new café to be known as the 'Brooklands Café'. The café to be situated in Brooklands Park, Western Road, Worthing, BN15 8RX.

The application sought authorisation for the sale of alcohol for consumption on & off the premises:

Committee Hearing: Held on Monday 21 August 2023

Two relevant representations were received from members of the public and one was received from a responsible authority - Sussex Police.

The Licensing Act encourages mediation and this had been successfully carried out between the applicant & Sussex Police resulting in a number of conditions of licence being agreed which had resulted in Sussex Police withdrawing their objections.

Mediation with the remaining representors was unsuccessful so the application was referred to a Licensing & Control Sub-Committee to consider at hearing.

The Sub-Committee considered all the written & oral representations and heard statements from the applicant. It resolved that a premises licence should be granted with all of the amendments agreed with Sussex Police.

The grant of the licence to be subject to all the relevant conditions volunteered by the applicant in the operating schedule and the mandatory conditions required by the Licensing Act 2003 and all other relevant legislation.

The Sub-Committee considered:

- The representation made by the Responsible Authority
- The mediation during which the applicant had amended the application and operating schedule
- The remaining relevant representations which had not been withdrawn
- The Committee also gave regard to human rights legislation and the rules of natural justice.

In discharging its functions the Sub-Committee did so with a view to promoting the Licensing objectives.

The Licensing Sub-Committee noted that during mediation with Sussex Police the applicant had agreed to numerous additional conditions, detailed at paragraph 8.2 of the report. The Licensing Sub Committee was satisfied that with the addition of these conditions, and the sale of alcohol being restricted to consumption on the premises only, the licensing objectives would not be undermined.

The Responsible Authorities (Sussex Police & WSCC Public Health Dept.) and the applicant had mediated successfully and agreed a number of amendments to the application. The application now sought:

 - Late night refreshment and provision of regulated entertainment to match the opening hours

The Sub-Committee considered all the written & oral representations and heard statements from the applicant. It resolved that the variation to the premises licence should be granted with all of the amendments

agreed with the responsible authorities. The grant of the licence subject to all the relevant conditions volunteered by the applicant in the operating schedule and the mandatory conditions required by the Licensing Act 2003 and all other relevant legislation.

The Sub-Committee considered:

- The representations made by the Responsible Authorities
- The mediation during which the applicant had amended the timings applied for
- The remaining relevant representation which had not been withdrawn
- The Committee also gave regard to human rights legislation and the rules of natural justice. In discharging its functions the Committee did so with a view to promoting the Licensing objectives.

The Committee listened carefully and considered all written and oral representations that were made. The Licensing Sub-Committee noted that the variation to the hours, agreed after mediation, would only constitute an additional 40 minutes to the opening hours, and licensable activities on Friday nights and an additional 10 minutes to the opening hours and licensable activities on Saturday nights and, as such, the Licensing Sub-Committee was satisfied that along with the amended condition, the licensing objectives would not be undermined.

Fat Greek Taverna

An application for a 'minor variation' to the premises licence at the 'Fat Greek Taverna'. The restaurant is situated at 18-22 Portland Road, Worthing, West Sussex, BN11 1QN. The licence authorises the sale of alcohol for consumption on the premises and the sale of late night refreshment.

Licence holder and applicant: Oyster Foods Ltd. t/a Patty Guy

Consultation closed: Monday 10 July 2023 **Committee Hearing:** Cancelled - not required.

No relevant representation was received from members of the public, but two were received from responsible authorities - Sussex Police and A&W Councils' Environmental Food Team.

The Licensing Act encourages mediation and this was conducted successfully with the applicant addressing the responsible authorities' concerns by volunteering a number of enforceable conditions to the licence's operating schedule. As a result they withdrew their representations and consequently, the amended application was granted as applied for as per the terms of the Licensing Act 2003.

Ideal Supermarket

An application for a new premises licence for a convenience store known as 'Ideal Supermarket'. The shop is situated at 55-57 Rowlands Road, Worthing, BN11 3JM

The application sought authorisation for the sale of alcohol for consumption off the premises.

The applicant offered a set of conditions in the operating schedule to address the licensing objectives.

Licence holder and applicant: Ali's Supermarket Ltd.

Consultation closed: Tuesday 20 June 2023

Committee Hearing: Held on Monday 17 July 2023.

Three representations were received regarding this application. Mediation was not conducted, so the application was referred to the Licensing & Control Sub-Committee to be considered.

At the hearing the Sub-Committee resolved not to grant a licence.

The Committee have listened carefully and considered all the evidence before them and was surprised to learn that the Applicant had not considered the advice that was given at the last hearing to approach Trading Standards and Sussex Police before submitting another application and consequently found the same application was before them again with the same representations from the responsible authorities.

The Sub-Committee found it concerning that when the Applicant was asked to name the licensing objectives he was unable to name any. The Applicant has just completed the personal licence exam and was the proposed DPS for this premise. This did not give the Committee confidence that the licensing objectives would be upheld.

Due to the particular sensitivity of the proposed area the committee had no confidence that the Applicant would be able to deal with challenges that running a business selling alcohol would encounter in this location.

The committee was asked to consider evidence that the applicant has a financial link to another property in the vicinity that was selling illicit tobacco and that the Applicant's car was found to contain a large quantity of illicit tobacco. The committee viewed this as further evidence that the Applicant would not promote the licensing objectives.

It was therefore felt proportionate and justified not to grant a licence.

The Committee listened carefully and considered all written and oral representations that were made. They did however consider evidence before them of Public Nuisance namely noise. To address this concern the Committee gratefully accepted the condition offered by the applicant during the hearing to move the portable tables and chairs from outside the front to the side of the premise (adjacent to Tarring Road) within the marquee, not to be used, and this is to be achieved by 22:00hrs. This condition coupled with the condition offered by the Applicant in relation to the portable table and chairs and with the condition agreed with Sussex Police to cease using the outside space from 22:00hrs should ensure that this premise does not cause a noise nuisance late at night.
