I Introduction

- 1.1 Worthing Borough Council undertook public consultation on its Regulation 19 Submission Draft Worthing Local Plan for a period of eight weeks commencing on 26th January 2021 closing on 23rd March 2021. This followed consultation on the Regulation 18 Preferred Approach Draft Local Plan in 2018.
- 1.2 This Consultation Statement provides an audit trail of the consultation, an assessment of what consultation methods worked well and which methods were not so effective. It is essential that the Council undertakes this evaluation to help shape future consultations, have an understanding of best practice as well as to inform the Adur and Worthing Joint Statement of Community Involvement (SCI) (2019) which will next be reviewed in 2024 following the legal requirement that an SCI must be reviewed every five years.

2 Background

- 2.1 The Submission Draft Local Plan, when adopted, will provide a strategy for sustainable development and change in Worthing borough up to 2036. The process of preparing a new Local Plan is made up of a number of statutory stages¹ when residents, businesses and other stakeholders are asked to comment on the Council's proposals. The first stage of consultation, the 'Issues and Options' stage was undertaken in 2016 when the Council sought views on how Worthing should grow and develop. The responses informed the Draft Local Plan (published for consultation at the end of 2018) that set out the Council's preferred options to address the issues that had been identified.
- 2.2 This period of public consultation forms the 'Publications stage' of the preparation of Worthing's Local Plan. This is the version of the Plan that the Council considers to be legally compliant and 'Sound' for submission to central government for independent Examination by a government appointed Planning Inspector.

3 Temporary Consultation Practices

- 3.1 In light of restrictions in response to the unprecedented nature of the Covid-19 Pandemic and continuous national lockdown restrictions, Adur & Worthing Councils have implemented temporary changes to public consultation procedures and planning practices. An Interim Addendum (January 2021) on the SCI was published.
- 3.2 The Chief Planner of Ministry of Housing, Communities and Local Government (MHCLG) provided an update in the December edition of the 'Planning Newsletter' (circulated to

Local Planning Authorities) regarding Plan Making. In response to concerns raised by local planning authorities and other stakeholders about the implications of Covid-19 on plan making, MHCLG published guidance on reviewing and updating statements of community involvement and on how authorities should consider the practical measures needed to ensure fair participation is possible at this time. MHCLG also temporarily removed legal requirements to make certain development plan documents available for inspection at premises and to provide hard copies on request. The documents must, instead, be made available for inspection online. These temporary changes expire on 31 December 2020 and because of the continuing uncertainty about the spread of Covid-19, these Regulations roll forward these changes for another 12 months to 31 December 2021.

3.3 The requirement to make documents available in line with Regs 35 and 36 applies to the publication of the plan (Reg 19), the submission of the plan for examination (Reg 22), the notifications relating to the examination under Reg 24 and to the adoption or withdrawal of the plan (Regs 26 and 27). The amended regulations can be found below:

- 3.4 These further temporary changes will support local planning authorities to continue to progress up-to-date Local Plans and spatial development strategies.
- 3.5 The Council at is discretion, considered it appropriate to extend the standard period for consultation to ensure as many interested parties as possible get an opportunity to comment. The Worthing Local Plan Regulation 19 Publication stage was extended to eight weeks (from 6).

4 **Overview of Consultation Process**

- 4.1 The E-form was prepared by the Council to collect responses and it was used by 19 respondents. The E-form enables representations to be processed in an efficient and timely manner. However, the popular mode of submitting representations was by email with some comments being submitted as hand written forms or letters. The variety of communication methods used to submit comments highlight that it is important to ensure that accessible and flexible range of methods are available.
- 4.2 The campaign co-ordinated by the Council's Communications Team was particularly effective. As an example, during the consultation period:

- 4 Facebook posts were placed that received over 5,858 total impressions (how many times it appears on a screen) with an average reach of 1,465 per post.
- 9 twitter posts were placed which resulted in over 11,467 total impressions with an average reach of 1,147 per post
- 3 Planning Policy blogs posts on the Council's website
- the Worthing Local Plan section of the Council's website received 1,071 page views.
- 4.3 The Council had a dedicated webpage on the Submission Draft Worthing Local Plan (See Appendix 1). The Council also maintains a 'Consultation and engagement' webpage advertising all live Council led consultations (See Appendix 2). During public consultation, a wide variety of social media methods (Facebook, Twitter and Blogs) were used to engage with interested parties. A press release was also issued on the Council's homepage (refer to Appendix 3).
- 4.4 All Worthing Borough Councillors were notified of the consultation as well as those registered on the Worthing Planning Policy 'Keep Informed' database.
- 4.5 Please refer to the Appendix 4 of this report to view screenshots of the consultation posts posted on Facebook, Twitter and Planning Policy blogs.
- 4.6 The local newspaper, The Worthing Herald ran an article on 'Have your say on vision for future of Worthing' (published on 29th January 2021). The online article can be viewed here: <u>https://www.worthingherald.co.uk/news/politics/have-your-say-vision-future-worthing-3117503</u>
- 4.7 Whilst the Council were unable to provide hard copies of the consultation documents on deposit, the Council communicated in consultation material that in certain circumstances, the Council will be happy to provide hard copies of the Local Plan to specific groups, particularly those with limited internet access.

5 Level of Response

5.1 The Council received 103 written representations, 55 representations from individual members of the public and 48 representations submitted by organisations. The submitted representations can be viewed in full online at on the Councils' website:

5.3 Overall, whilst lessons can always be learned for future work of a similar nature, it is considered that the consultation was a success despite being a wholly online consultation during a national lockdown. The extension of the statutory six week consultation period to eight weeks was certainly beneficial. The use of an E-form worked well and the Council can clearly demonstrate how a variety of online and social media methods were used to engage with a high number of groups / individuals. Whilst this engagement would have helped to generate the representations received, it should also be acknowledged that the content of the consultation (particularly the inclusion of greenfield sites, the allocation of Lyndhurst Road, the proposed designation Local Green Gaps and Local Green Spaces) is likely to have driven a higher level of interest than would otherwise have been the case.

Introduction

Worthing Borough Council recognises the importance of having an up to date Local Plan in place that can enable 'local decision making' and guide development that is sustainable, inclusive and resilient. After a number of years of preparation the Council is publishing its final version of the Plan for comment before it is submitted for independent Examination.

The Council appreciates that these are difficult times to undertake this consultation. However, Government advice is clear that Council's should continue to progress their Local Plans and, to support this aim, changes to consultation regulations have been made at the national level to ensure that this can happen. Despite this, the Council wants to ensure that all interested parties have an opportunity to be involved at this stage. To achieve this and to help mitigate the impacts of Covid-19 restrictions the consultation period has been extended from 6 to 8 weeks. This consultation will run from Tuesday 26th January until 5pm Tuesday 23rd March 2021. Any responses received after this date will not be accepted.

So, what has been done so far ...

The plan has already been through two rounds of public consultation:

- Firstly in 2016 the <u>'Issues and Options 'Your Town -</u> <u>Your Future'</u> (identified key issues and asked for views on how they should be addressed)
- Secondly in Oct 2018 Second <u>'Draft Local Plan'</u> -(Preferred Options)

The comments submitted at these two consultations have been considered and have helped to shape the Plan. The Plan has also been informed by a comprehensive evidence base and, using this information, Worthing Borough Council considers that the Local Plan that is now published for comment is 'sound' and establishes a clear and robust strategy for the Borough.

What are the key outcomes for the new Local Plan?

The Local Plan will be a key document in shaping the future of the borough over a 15 year period as it provides the strategy for growth, setting out what development will take place and where. When adopted, the new Plan will replace the borough's existing local planning policies and will be an important consideration in deciding planning applications.

The Plan builds on national guidance to provide for more specific local policies for Worthing to create a high quality environment. It has been a very difficult task to balance all the identified needs of Worthing's communities with the scarcity of land that we have within the borough. Some of the key elements of the new Plan are to:

- plan positively for growth and contribute to sustainable development
- balance development alongside protecting jobs, community facilities and valued open spaces
- embed the United Nations Sustainable Development Goals
- establish: 3 Strategic Policies; 6 Spatial Policies; and 24 Development Management policies
- allocate 15 sites for development (6 on edge of town and 9 redevelopment sites within the existing built up area).

Final consultation on draft Worthing Local Plan

Released: Tuesday, 26 January 2021

An ambitious vision to provide high-quality homes, sustainable workplaces and green space for future generations in Worthing is entering its final stage - with interested parties now having one last opportunity to comment on the document.

After five years in the making and input from hundreds of residents, businesses and stakeholders, the draft Worthing Local Plan is now ready to be formally submitted. If adopted, it will guide the development of the town for the next 15 years.

Central to the vision is the creation of 4,600 additional sustainable homes, primarily on brownfield sites such as Teville Gate and Union Place, while large open spaces, such as Brooklands Park, Goring Gap and Chatsmore Farm, will be preserved and enhanced for generations to come.

A key driver to the document is sustainability with Worthing Borough Council one of the first in the country to embed United Nations Sustainable Development Goals into their development plan.

Ahead of the plan being submitted to the government, interested parties are invited to comment on the legal soundness of the final draft plan.

The COVID-safe consultation will run online only for eight weeks (rather than the usual six) until 23rd March 2021.

This input will then be provided directly to the Government appointed Planning Inspector so that they can make a fair assessment on the detailed document.

Cllr Kevin Jenkins, the Council's Executive Member for Regeneration, said:

"The Worthing Local Plan has been years in the making. After considering valuable input from residents and a range of partners, I believe the final document provides a clear sense of our determination to craft and grow our town to create a community that can thrive now and for generations to come.

"Like our residents, we have high ambitions for our places, our communities and their futures. We respect the fascinating histories that have made us what we are and we intend to build upon them to develop prosperous, flourishing and healthy communities for the long term.

"It also underlines our ambition to address local and national issues, whether that be housing provision or climate change.

"I'm pleased we have now reached this final stage and look forward to the government reviewing the final document, along with any further comments, later this year."

22nd February 2021: Only four weeks left to go ...!

We have almost reached the halfway point on the Submission Draft Worthing Local Plan consultation with just four weeks left to go!

You may be interested to hear that the Council has taken a visionary and new approach of including the United Nations Sustainable Development Goals (UN SDGs) within the Plan.

The SDGs consist of 17 interconnected goals underpinned by targets designed to achieve a better and more sustainable future for all. They address the global challenges we face, including those related to poverty, inequality, climate change, environmental degradation, peace and justice. The goals form part of the 2030 Agenda for Sustainable Development, which is a call for action by all UN member states. It is considered that the UN SDGs will enhance the sustainability credentials of the Plan and thus will provide a more robust monitoring framework.

The UN SDGs are becoming increasingly recognised and adopted by numerous public, private and voluntary sector organisations, therefore working towards a common and shared consensus for sustainable development.

I would also like to shine a spotlight on 'Strategic Policy SP2: Climate Change' which is an overarching policy designed to ensure that the impacts of climate change are fully considered at an early stage to ensure that future development and associated infrastructure is future proofed and resilient to recover from extreme weather conditions.

The planning system is one of many tools that can be used to help minimise vulnerability to all sectors of the community. The way in which we shape new and existing development in Worthing can make a significant contribution to adapting and mitigating the effects of climate change through carbon reduction (decarbonisation) and sustainable design and construction.
