Proposed Article 4 Direction Consultation Response Form

As part of a programme of reviewing and updating conservation area character appraisals across the district, Adur District Council has prepared draft character appraisals for the Old Shoreham and Kingston Buci conservation areas.

The draft character appraisals propose introducing stricter planning controls, known as an Article 4 Direction, to preserve the unique character of properties in the area.

Adur District Council made an Article 4 Direction for Old Shoreham on 25 November 2021. The Council made an Article 4 Direction for Kingston Buci on 15 December 2021. The Council is inviting residents of the Kingston Buci and Old Shoreham Conservation Areas for their views on the Direction. The responses from the consultation will be taken into account when considering whether to confirm the Direction.

The Article 4 Directions will be the subject of an eight-week period of formal public consultation.

- **Old Shoreham from Thursday 25 November 2021 until Thursday 20 January 2022.**
- **Kingston Buci from Thursday 16 December 2021 until Thursday 10 February 2022.**
