## Schedule of charges for Adur and Worthing Street Naming and Numbering Service

*These charges will apply from 1<sup>st</sup> April 2022 to 31<sup>st</sup> March 2023  
and will incur a further 5% increase per annum thereafter until further notice.*

House name or number Change.	£90.00	Covers the cost of investigations consultation with Royal Mail and notification to internal and external organisations, officer time and resources.
Building Name Change	£120.00 + £38.00 per flat/unit	Covers the cost of investigations, consultation with Royal Mail and notification to internal and external organisations, officer time and resources.
Change of street name where requested by residents.	£242.00 + £90.00 per property	Covers the cost of investigations and consultations with Royal Mail, local councils and internal and external organisations, officer time and resources for all amendments.
New developments including conversions of residential and commercial premises  <b>RETROSPECTIVE ADDRESSING:</b>	£242.00 per phase + £38.00 per plot/unit. £120.00 per additional building name  <b>£302.00 per phase</b> <b>£66.00 per plot</b> <b>£120.00 per additional building name</b>	Covers the cost of investigations, building name consultations where required and notification to internal and external organisations, officer time and resources.
Street naming for new developments.	£253.00 per street	Covers the cost of investigations and consultations Royal Mail, West Sussex County Council, West Sussex Fire & Rescue Service, local councils and notification to internal and external organisations, officer time and resources.
Amending schedule of development already issued following plot changes by developer.	£90.00 per plot affected	Covers the cost of notification to internal and external organisations, officer time and resources.

Street numbering request for existing street where previously only named houses.	No fee	It is in the interests of the Council to have all roads numbered.
Issuing of amended address information following an error on database or Royal Mail PAF.	No fee	Where an error has occurred it is not reasonable to charge to resolve the problem. If the issue arises because SNN has not been requested, then new development charges will apply.
Where a property owner requires a letter confirming their official property address to present to services such as solicitors, banks, mortgage companies and other service providers.	£49.00	Covers the cost of the time, investigation and resources for the service. This type of request is required to be dealt by the Street Naming and Numbering Officer.

Anyone requiring a new address, new street name or plot amendment should first:

- Complete a Street Naming and Numbering application form online or download and post to the address below. The application form can be found by visiting: <https://www.adur-worthing.gov.uk/naming-and-numbering/>
- The Street Naming and Numbering Officer will acknowledge your application, confirm total costs allocating a SNN reference number to quote when making payment.
- Once the Street Naming and Numbering application has been accepted, payment of fees can be made online using the same secure online form at: <https://www.adur-worthing.gov.uk/naming-and-numbering/>
