

# Expression of Interest (EOI) for temporary use under a trial licence

For the use of the indoor Pavilion rooms & Open Spaces at Beach House Park Worthing Borough Council

Worthing Borough Council is inviting expressions of interest for the use of **indoor pavilion rooms and adjacent open spaces** at Beach House Park from **September 2025 and September 2026**.

These spaces are part of the **Central Leisure & Community Zones**, designed to support inclusive, creative, and wellbeing-focused community activities. We welcome ideas that could form the basis of **Ionger-term initiatives**, building on successful models tested during this trial.

## **Indoor Pavilion Rooms - Community Zone**

Located within the Community Zone, the new pavilion offers flexible indoor space for:

- Arts, heritage and cultural practices or workshops
- Exhibitions and small events
- Social clubs and community-led initiatives

Proposals should include opportunities for community engagement and may include **innovative fundraising approaches** to support ongoing use.

## **Open Spaces - Wellbeing & Leisure Zone**

The former bowls green and adjacent hard standing are available for:

- Wellbeing and fitness sessions to promote physical activity and reduced stress
- Performances or installations reflecting the park's tranquil and peaceful ambience
- Seasonal or community markets or fetes
- Community garden with educational, sensorial and/or horticultural values

### Key information

- Activities must be temporary, safe, inclusive, and community-focused
- Groups to be open to developing their offering with community feedback
- Available: September 2025 to September 2026, with a view to extend if the model is successful. This will be assessed based on 6 criteria: number of people involved, range



of activities offered, positive community feedback, involvement of local groups, regular use of the space and competency to manage the assets sustainability.

- Food and drink concessions will not be considered
- Proposals must respect the historic character and natural setting of the park. All units and equipment should be traditional, elegant, and understated, blending in with the landscape. All proposals must follow conservation rules and enhance the park's visual and cultural heritage.



New Pavilion floor plan (pic A3)




