TOWN AND COUNTRY PLANNING ACT, 1947

TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER, 1950.

WHEREAS Article 4 of the Town and Country Planning General Development Order, 1950, (hereinafter called "the said Order") provides, inter alia, that if the Local Planning Authority is satisfied that it is expedient that development of any of the classes specified in the First Schedule to the said Order should not be carried out in any particular area, or that any particular development of any of those classes should not be carried out, unless permission is granted on an application in that behalf, the Local Planning Authority may direct that the permission granted by Article 3 of the said Order shall not apply to:-

- (a) all or any of the development of all or any of those classes in any particular area specified in the direction, or
- (b) any particular development, specified in the direction, falling within any of those classes.

NOW THEREFORE the Urban District Council of Shoreham-by-Sea on behalf of the County Council of the Administrative County of West Sussex, being satisfied that it is expedient that the development specified in class XI of the First Schedule to the said Order should not be carried out on the land described in the Schedule hereto unless permission is granted on an application in that behalf, in pursuance of the powers conferred upon them by Article 4 of the said Order HEREBY DIRECT that the permission granted by Article 3 of the said Order shall not apply to the development specified in Class XI of the First Schedule to the said Order on the land described in the Schedule hereto.

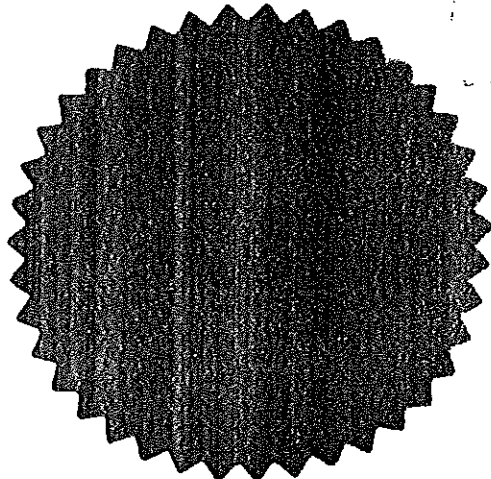
THE SCHEDULE ABOVE REFERRED TO

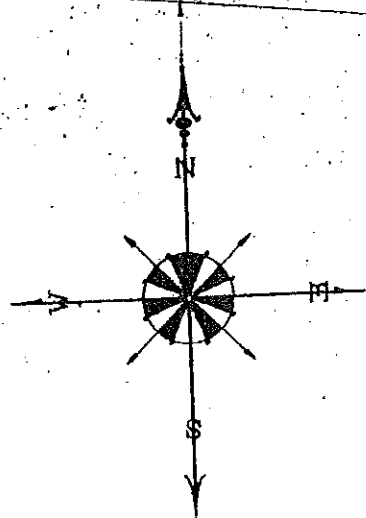
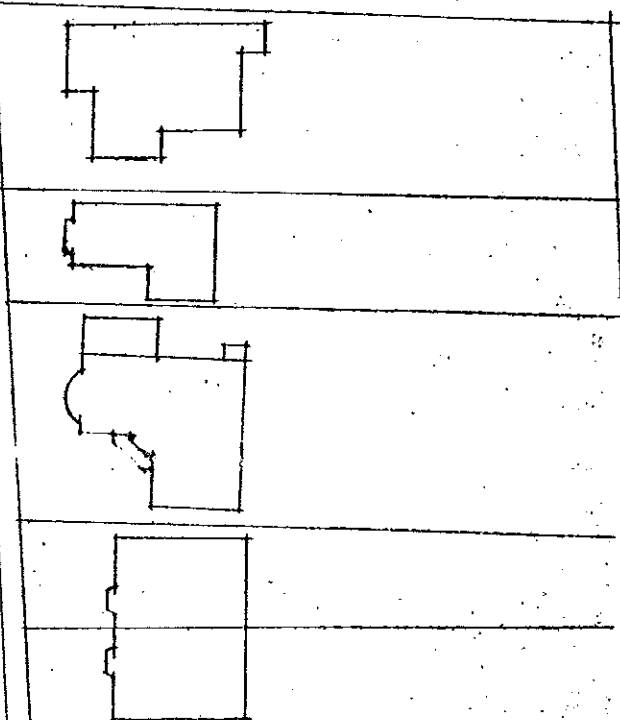
