DEVELOPMENT ORDERS 1977-81

WHEREAS The Borough Council of Worthing (hereinafter called "the Council") the local planning authority for the said Borough are satisfied that it is expedient that development of the description set out in the Schedule hereto (hereinafter called "the development") should not be carried out on land in the said Borough shown edged red on the plan annexed hereto unless permission therefor is granted on application made in accordance with Article 5 of the Town and Country Planning General Development Order 1977 (hereinafter called "the Order")

NOW THEREFORE the Council in pursuance of the powers conferred upon them by Article 4(1) of the Order hereby direct that the permission granted by Article 3 of the Order shall not apply to development on the said land of the description set out in the Schedule hereto

SCHEDULE

The carrying out of building or engineering operations requisite for the use of the land edged red on the plan annexed hereto for the purposes of agriculture being development comprised within Class VI referred to in the First Schedule to the said Order and not being development comprised within any other Class.

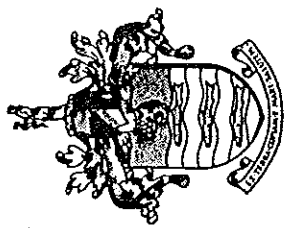
