ARTICLE 4 (2) DIRECTION REMOVING PERMITTED DEVELOPMENT RIGHTS

NOTICE IS HEREBY GIVEN THAT THE ADUR DISTRICT COUNCIL have made a Direction under Article 4 (2) of the Town and Country Planning (General Permitted Development) Order 1995 removing permitted development rights in respect of properties in Church Street, Shoreham by Sea, as shown on the plan attached, to the following extent: -


- 1 of Schedule 2, consisting Class A of Part (a) other alteration enlargement, improvement or dwellinghouse, where any part of the enlargement, improvement or alteration would front a relevant location;
- Class C of Part 1 of that Schedule, where the alteration would (b) be to a roof slope which fronts a relevant location;
- Class D of Part 1 of that Schedule, where the external door in (C) question fronts a relevant location;
- Part 1 of that schedule consisting of the erection, alteration (d) or removal of a chimney on a dwellinghouse or on a building within the curtilage of a dwellinghouse;
- Class A of Part 2 of that Schedule, where the gate, fence, (e) wall or other means of enclosure would be within the curtilage of a dwelling-house and would front a relevant location;
- Class C of Part 2 of that Schedule, consisting of the painting (f) of the exterior of any part, which fronts a relevant location,
 - a dwelling-house; or (i)
 - (ii) any building or enclosure within the curtilage of a dwellinghouse.
- (g) Class B of Part 31 of that schedule, where the gate, fence, wall or other means of enclosure is within the curtilage of a dwellinghouse and fronts a relevant location.

"(NB "relevant location" means a highway, waterway or open space).

A copy of the direction and a copy of the map defining the area to which it relates may be inspected at Civic Centre, Ham Road, Shoreham by Sea on weekdays between 10.00 am and 4.00 pm.
