- 2. Traders will need to set-up at a vacant concession pitch. Current availability can be checked with our Concessions Team
- 3. All food businesses must have a Food Hygiene Rating of at least a 4, and be live on the FHR register at https://ratings.food.gov.uk/
- 4. Pitches are intended for 'Food' use only. This does not include Cafe Refreshment Units or Ice Cream Vans but can include Smoothies and Milkshakes, Juice Bars, and Pop-Up Bars (providing a TEN or valid personal licensing is in effect)
