Exempt properties

- B Empty properties owned by a charity. Please give the name of the charity and its registration number with the Charity Commissioners.
- D Empty properties where the person responsible for paying Council Tax is in prison or any other form of detention (we will need to see a letter from the prison or detention centre).
- E Empty properties where the person responsible for paying Council Tax is living in a hospital or care home (we will need to see a letter from the hospital or care home).
- F Empty properties that have been empty since the person responsible for paying Council Tax has died.
- G Empty properties where occupation is against the law (we will need to see a copy of the lease or agreement explaining why the occupation is illegal).
- H Empty properties held for a minister of religion (we will need to see a letter from the church).
- Properties left empty by a person receiving care somewhere else (we will need a letter from the doctor involved).
- J Properties left empty by a person providing care somewhere else (we will need a letter from the doctor involved).
- K Properties owned by a student and left empty (we will need a certificate from the college). Please see below for a definition of 'student'.
- L Properties repossessed by a mortgage lender (we will need a letter from the mortgage lender).
- M Occupied students' halls of residence.
- N Properties occupied only by students (we will need certificates from the college for all of the students). We will need a list of all the residents.
- O Properties owned by the Secretary of State for Defence or UK armed forces personnel.
- P Properties owned by visiting armed forces personnel.
- Q Properties left empty by a bankrupt person (we will need a letter from the trustee).
- R Empty caravan pitch or boat mooring (we may need to inspect this).
- S Properties occupied only by people under 18 (we will need to see birth certificates).
- T Empty extensions that form part of a property occupied by the person making this application and which cannot be let separately without breaking planning permission.
- U Properties occupied only by a severely mentally disabled person, or a mixture of severely mentally disabled people (we will need a letter from the doctor).
- V Properties occupied only by people with diplomatic immunity.
- W Occupied extensions that form part of a single property with another property occupied by a dependent relative.

A student is someone on a full-time or qualifying course of education, including nurses following Project 2000 courses and foreign language assistants.

All the exemptions have no time limits, apart from B which last for up to six months and ends as soon as someone else moves into the property. Class F properties are exempt for a maximum of six months from the date of probate.

If you have a property that has an exemption, you must tell us immediately if someone moves into the property or the property is used for something different.
