### Licensing Act 2003 - Applications completed in 2024

**Please find below a list of Licensing Act 2003 applications completed since 1 January 2024 by the Licensing Authority, Adur District Council, for new Premises Licences, Variations to existing Premises Licences and Review applications.**

The terms of the Licensing Act 2003 dictate that all 'new' applications and 'variation' applications are publicised and consulted on. If no representations are received from 'Responsible Authorities' or any other persons such applications must be granted as applied for. If relevant representations are received and mediation between the parties is unsuccessful then the application has to be deliberated by the Licensing Committee following a hearing.

'Minor variations' are also consulted on but only by 'public notice' on the premise, details posted on this website and any responsible authorities the licensing authority selects as relevant. If relevant representations are received and considered by officers to have implications under the licensing objectives then the application is simply rejected and a full variation has to be applied for.

'Review' applications are consulted on by public notices being displayed on the premise and on the licensing authority's notice board situated at the Shoreham Centre. Details are posted on this website and copies of the application are served on the licence holder and responsible authorities. Review applications cannot be withdrawn unless a licence is surrendered and must be heard by the Licensing Committee whatever agreement mediation may produce.

#### Co-op, Southwick Square

An application for a 'Minor Variation' to the premises licence at the 'Co-op' convenience store. The store is situated at 8-16 Southwick Square, Southwick, West Sussex, BN42 4FJ.

The premises licence authorises the sale of alcohol for consumption off the premises between 08:00hrs and 23:00hrs Monday to Sunday.

The application sought to vary the licence to authorise:

- Changes to the internal layout of the premises

No other changes were proposed.

on the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representations were received from members of the public or the authorities consulted. After due consideration officers considered the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation application was granted as per the terms of the Licensing Act 2003

The applicant addressed the representor's concerns by volunteering an enforceable condition to the licence's operating schedule to address the Police's concerns. As a result the representation was withdrawn and consequently, an amended application was granted as per the terms of the Licensing Act 2003.

### **Marks & Spencers**

An application for a 'minor variation' to the premises licence at 'Marks & Spencers'. The store is situated at the Holmbush Centre, Upper Shoreham Road, Shoreham-by-Sea, West Sussex, BN43 6TD

The premises licence authorises the sale of alcohol for consumption on & off the premises between 08:00hrs & 23:00hrs Monday to Saturday and 10:00hrs & 22:30hrs Sunday.

The application sought to vary the existing Licence to authorise:

- Changes to the ground floor layout of the retail area with changes to the till points.

No other changes were proposed.

impact on the licensing objectives, Sussex Police, WSCC Fire & Rescue Service and the A&W Environmental Health Team were consulted.

No formal representations were received from members of the public or the authorities consulted. After due consideration officers considered the changes proposed unlikely to have an adverse effect on the licensing objectives. Consequently, the minor variation application was granted as per the terms of the Licensing Act 2003.

The Licensing Act encourages mediation, and this was conducted between the applicant and Sussex Police with the applicant addressing the representor's concerns by reducing the hours for the sale of alcohol by 30 minutes per day to 12:00hrs to 21:30hrs Monday to Sunday as well as by volunteering a set of conditions on the licence's operating schedule. As a result, the representation was withdrawn and consequently, an amended application was granted as per the terms of the Licensing Act 2003.

### **Samy's Cafe Bar**

An application for a 'minor variation' to the premises licence at the 'Samy's Cafe-Bar'. The cafe is situated at 48-52 High Street, Shoreham-by-Sea, West Sussex, BN43 5DA.

The premises licence authorised the sale of alcohol for consumption on the premises between 08:00hrs & 22:30hrs Monday to Saturday and 09:00hrs & 22:00hrs Sunday. The application sought to vary the existing Licence to authorise:

Amend the following condition of licence:

- No vertical drinking - alcohol can only be served at tables to accompany a meal.

Replace with the following enforceable condition:

- No vertical drinking - alcohol can only be served at tables by waiter or waitress service during the course of normal business. The exception being when advertised events featuring live music are being staged at the premises when vertical drinking will be permitted.

  - 12:00hrs to 20:00hrs Sunday

The Licensing Act encourages mediation and this has been conducted with all representors with the applicant addressing the representors concerns by volunteering a set of conditions onto the licence operating schedule and amending the licensable hours on the Sunday to:

- Live music:
  - 11:00hrs to 22:30hrs Saturday

## Funky Dragon

An application for a 'minor variation' to the premises licence at the Funky Dragon. The restaurant is situated at Town Hall, 45-49 High Street, Shoreham-By-Sea, West Sussex, BN43 5DD.

The premises licence authorises the sale of alcohol for consumption on and off the premises between 09:30hrs and 01:00hrs each day. The application sought to vary the existing licence to:

- Authorise a change the layout of the restaurant in regard to the relocation of the bar in accordance with the presented plan.
- Remove the following conditions of licence:
  - The supply of alcohol shall be by waiter/waitress service only throughout the premises.
  - Alcohol will only be served to people taking table meals at the premises. There will be no vertical drinking.
- Replace with to following enforceable conditions:

- The supply of alcohol shall be by waiter/waitress service only throughout the premises, except for the area adjacent to the bar where existing customers can order drinks and consume them at the bar before or after their meal. Customers will not be permitted to purchase alcohol without dining.
- There will be no vertical drinking in the premises except in the designated bar area as described above or when the whole premises is closed to the public for a pre-booked private party/function that Sussex Police Licensing have been notified of 10 days in advance.

## Wine Me Up

An application for a review of the premises licence at 'Wine Me Up' under section 51 of the Licensing Act 2003. The store is situated at 29 Brunswick Road, Shoreham-by-Sea, West Sussex, BN43 5WA.

The store's premises licence permitted the sale of alcohol for consumption off the premises between 06:00hrs and 23:00hrs Monday to Sunday.

The application was submitted by WSCC Trading Standards Service and requested that the Licensing Authority considered:

- revocation of the premises licence

The grounds for review being the applicant contended the following licensing objectives were not being continually upheld at the premises:

- the prevention of crime and disorder
- public safety
- the protection of children from harm

Following the discovery of a substantial quantity of illicit tobacco & vapes at the store and various breaches of the premises licence conditions.

**Committee Hearing:** Cancelled - Licence Surrendered

On 5 June 2024 the licence holder formally surrendered the premises licence in accordance with section 28 of the Licensing Act 2003. Consequently, the sale of alcohol from this premises is no longer authorised.

## Long Feng Han Foods Ltd

An application for a review of the premises licence at 'Long Feng Han Foods Ltd' under section 51 of the Licensing Act 2003. The store is situated at 18 Southwick Square, Southwick, West Sussex, BN42 4FJ.

The store's premises licence permitted the sale of alcohol for consumption off the premises between 08:00hrs and 22:00hrs Monday to Sunday.

The application was submitted by WSCC Trading Standards Service and requested that the Licensing Authority considered:

  - However on no more than twice in a calendar month the premises will operate a ticket only event limited to no more than 15 customers who will be on the premises undergoing an alcohol tasting educational session and may be allowed to purchase glasses of alcohol after the tasting session is completed for consumption on the premises.
  - This will generally be wine but may include other specialist alcohols such as beer or cider. These sessions will run for no longer than 3 hours on any one occasion.
  - When the premises is operating its On Sales customers can remain on the premises until 22:30.

**Licence holder and applicant:** Mrs Verity Sessions

**Consultation closed:** Thursday 4 April 2024

**Committee Hearing:** Cancelled - not required.

The application received no relevant representation from members of the public, but one was received from a responsible authority - A&W Council's Environmental Health Food Team.

The Licensing Act encourages mediation and this was conducted with the applicant addressing the representors concern by volunteering an enforceable condition onto the licence's operating schedule. As a result the representation was withdrawn and consequently, an amended application was granted as per the terms of the Licensing Act 2003.

## **MacFarlanes**

An application for a review of the premises licence at 'MacFarlanes' under section 51 of the Licensing Act 2003. The store is situated at 21 Southwick Square, Southwick, West Sussex, BN42 4FP.

The store's premises licence permits the sale of alcohol for consumption off the premises between 06:00hrs and 22:00hrs Monday to Sunday.

The application was submitted by WSCC Trading Standards Service and requested that the Licensing Authority considered:

- suspension of the Premises Licence
- a change to the Designated Premises Supervisor (DPS)
- adding additional conditions to the Premises Licence

The grounds for the review being the applicant contends the following licensing objectives have been undermined by the carrying on of licensable activities:

- the prevention of crime and disorder
- the protection of children from harm

**Licence holder and applicant:** Shiv Enterprise / WSCC Trading Standards Service

**Consultation closed:** Monday 15 January 2024

**Committee Hearing:** Held on Monday 26 February 2024

The application received no representations from the public but did receive two representations from responsible authorities supporting Trading Standards case. These were from Sussex Police and WSCC Public Health. Both authorities, as well as endorsing the application's contention that the licence should be suspended and the DPS replaced, recommended a number of conditions be imposed to promote the licensing objectives.

At the hearing the sub-committee considered all the written and oral representations from the applicant, representors and licence holder.

The sub-committee resolved that:

- the licence should be suspended for one week
- the DPS should be removed and replaced
- the conditions recommended by Sussex Police and offered by the applicant should be added to an amended licence to replace the current conditions in place

In reaching its decision the Licensing Sub-Committee gave due regard to the following:

- The statutory licensing objectives.
- Worthing Borough Councils Statement of Licensing Policy.
- Guidance under section 182 by the Home Secretary and Licensing Act 2003.
- The application, written/oral representations made at the hearing and in writing.
- Human rights legislation and the rules of natural justice.

In discharging its functions the Committee did so with a view to promoting the Licensing Objectives, the relevant objectives here were

- the Prevention of Crime & Disorder and
- the Protection of Children from Harm.

The Committee heard that between May 2023 and June 2023 there had been complaints from parents in the local area that the premises were selling e-cigarettes to children under the age of 18, including one boy aged under 14. In addition, the premises failed a WSCC Trading Standards test purchase by selling an e-cigarette without challenge to a 16-year-old volunteer. There were also numerous breaches of the premise licence reported which were corroborated by Sussex Police during their inspection of the premises

The Committee had regard to the fact warnings had already been issued to the licence holder & DPS prior to the test purchase failure and felt that because underage sales are classed as criminal activity they should be treated particularly seriously. Therefore, the Licencing Sub-Committee felt it proportionate and necessary to suspend the premise licence for one week to ensure that the licensing objectives are upheld and serve as a deterrent for other premises in the locality. Clearly showing that the Licensing Authority will not tolerate this activity.

The sale of alcohol from the premises was suspended from 20 March to 27 March 2024.

---
