Executive Decision – Case of Special Urgency

In accordance with the provisions of procedure rule 17.6 of the Overview and Scrutiny procedure rules, as set out in the Council's Constitution, and Section 11 of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012, I hereby agree that the implementation of the exempt executive decision referred to below is urgent and cannot reasonably be deferred.

We are therefore in agreement that the following executive decision should not be subject to call in:

Title of Decision: Award of Contract for Fire Doors

Date of Decision to be taken: 30 June 2017

Reason why decision cannot reasonably be deferred:

Fire Risk Assessments (FRA's) have been completed on all Adur Homes blocks common parts and various internal meetings have discussed the outcome and recommendations from these FRA's. One of the outcomes is the need to replace approx 300 front entrance doors across the Adur Homes Estate as a priority. These are as a result of tenants/leaseholders replacing these doors themselves with non fire rated doors.

A project to replace these doors has been underway for the last few months and the recommended approach is to have a contract in place with an appropriate contractor to replace these doors and any others that our programme of Fire Risk Assessments identify as deficient.

Specification and tender documents were prepared for replacement front entrance doors across Adur Homes properties that do not meet the required standard. A handful of these properties that require new doors are in the two 6 storey blocks (Sea House and Grange Court).

Tenders have been invited and two have been received and these tenders are currently being analysed in detail by the Technical Services Surveying team. These tenders have now been received in accordance with the Councils Standing Orders Relating to Contracts. We would like to seek approval to award this contract early next week (week commencing 3rd July 2017). This is paricularly in light of the Grenfell tragedy where it is felt prudent to proceed at pace with the award and waive the 28 day notification period. There will be much to do once the contract is awarded including start up meetings and tenant liaison etc.

Contractors who supply and install fire doors are also now likely to be in great demand due to the recent tragedy.

The contract value is approx £350k for first year and the contract period can be extended to 4 more years if performance of the appointed contractor satisfactory.

The funding for the Fire Doors has been included in this year's, and future years Adur Homes Capital Investment Programme.
