Paying your Business Rates by Direct Debit

We want to make paying your Business Rates as simple as possible and the easiest way is by Direct Debit.

Almost eight hundred customers already enjoy the advantages of paying by Direct Debit which include

- Safety and security the Direct Debit guarantee protects you if anything should go wrong
- Convenience once you have returned your Direct Debit mandate the money comes out of your account regularly without you having to do anything
- No queuing to make a payment
- No more writing cheques or postage costs
- Monthly payment options with four dates available on the 1st, 8th, 15th or 25th of each month
- No late or missed payments

If you would like to join the many customers who currently pay by Direct Debit you can do this by completing the form on the reverse of this letter (ensuring that you include your eight-digit account number that's shown on your Business Rates bill) and then return it to us. We will aim to process your request within one month of receiving your form.

Once we have set up your Direct Debit we will write to you confirming that this has been done, but until you receive confirmation please continue to pay the Business Rates instalments that are shown on your bill by another method.

If you do not wish to pay by Direct Debit, you can also pay by PayPoint at many local shops using the PayPoint barcode that's on your Business Rates bill. A list of your nearest PayPoint outlets can be found at <u>www.paypoint.co.uk/locator</u>.

This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.

- If there are any changes to the amount, date or frequency of your Direct Debit, Adur District Council will notify you fourteen working days in advance of your account being debited or as otherwise agreed. If you request Adur District Council to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by Adur District Council or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society. You should contact your bank or building society to request a refund.
- If you receive a refund you are not entitled to, you must pay it back when Adur District Council asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify Adur District Council.
